**Missouri Real Estate Commission (MREC) and Greater Springfield Board of REALTORS® Continuing Education Rules and Regulations**

- Students must sign the course sign-in sheet located at the registration table. If a student is not signed-in he/she is not considered present for the class. Students must be signed-in for attendance to be considered valid for CE purposes.
- Students must be signed-in and seated in the classroom when the class begins. Students arriving late will not be allowed to enter the classroom and must pay for another course.
- Students must submit written notice to the Education Department at least 48 hours in advance of a scheduled class to cancel or transfer to another class at no additional charge or receive a refund.
- Continuing education requirements mandate 100% attendance during Continuing Education classes. No exceptions.
- There will be one (1) ten (10) minute break each hour. This is the only time students may leave the classroom. All business and personal issues must be handled during break times.
